ORDER

Granting Motion for *Pro Hac Vice* Admission of Yuan Liang 37 C.F.R. § 42.10

As authorized in the Notice of Filing Date Accorded to Petition (Paper 3), Petitioner, WhatsApp Inc. ("Petitioner"), moves for admission *pro hac vice* of Mr. Yuan Liang (Paper 24, "Motion").² Patent Owner, Triplay, Inc., did not file an opposition to the Motion. The Motion is *granted*. *See* 37 C.F.R. § 42.10(c); *see also* IPR2013-00639, Paper 7 (setting forth requirements for *pro hac vice* admission). ³

It is

ORDERED that the Motion seeking admission *pro hac vice* for Yuan Liang is *granted*;

FURTHER ORDERED that Yuan Liang is authorized to represent Petitioner as back-up counsel in this proceeding;

FURTHER ORDERED that a registered practitioner must remain as lead counsel throughout the proceeding;

FURTHER ORDERED that Yuan Liang is to comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials, as set forth in Part 42 of the C.F.R.; and

FURTHER ORDERED that Yuan Liang is to be subject to the Office's disciplinary jurisdiction under 37 C.F.R. § 11.19(a), and the USPTO Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101 *et. seq.*
