PETITIONERS' REQUEST FOR ORAL HEARING

Pursuant to 37 C.F.R. § 42.70(a) and the Board's Revised Scheduling Order (Paper 25), Petitioners<sup>2</sup> request oral argument on the instituted grounds of unpatentability for claims 1-4, 6, 8-11, 13, and 15-16 of U.S. Patent No. 8,218,481. The Board has scheduled an oral hearing for October 17, 2017 at 1:00 p.m. ET at the USPTO offices in Alexandria, Virginia. Paper 36 at 3.

Petitioners have conferred and agreed that:

- (i) counsel for ZTE will present on behalf of Petitioners as to grounds 1-9, which are based primarily on the Panasonic references (*see* Paper 24 at 4); and
- (ii) counsel for Apple/Microsoft will present on behalf of Petitioners as to grounds 10-17, which are based primarily on the IEEE802.16 references (*see* Paper 24 at 4-5).

Petitioners request the ability to use an overhead projector or other audio-visual equipment for demonstrative exhibits such as PowerPoint slides.
