

**DECLARATION OF ANDREW D. HEDDEN IN SUPPORT  
OF MOTION FOR *PRO HAC VICE* ADMISSION**

I, Andrew D. Hedden, declare that:

- 1) I am an associate at the law firm of Robins Kaplan LLP and provide this declaration in support of Patent Owner's Motion for my *pro hac vice* admission. I have personal knowledge of the matters set forth below, and if called as a witness, I could and would testify competently to these matters.
