PATENT OWNER'S REQUEST FOR ORAL ARGUMENT

Pursuant to the Board's September 21, 2016 Scheduling Order (Paper 14), Patent Owner respectfully requests oral argument for the trial currently scheduled on June 6, 2017 in this proceeding. Pursuant to 37 C.F.R. § 42.70, Patent Owner requests one hour of argument time and specifies the following issues, without intent to waive consideration of any issue not requested, to be argued.

ISSUES TO BE ADDRESSED DURING ORAL ARGUMENT

- I. Proper construction and scope of the claims.
- II. Ground 1: whether claims 1-5 are anticipated by Petrovic pursuant to 35 U.S.C. §102.
- III. Ground 2: whether claim 5 is obvious over Petrovic in view of Raith and Alakija pursuant to 35 U.S.C. § 103.

Patent Owner additionally requests permission to use audiovisual display equipment to present demonstratives, including a projector and screen for computer-generated slides. Any demonstrative exhibits will be served at least five business days before the oral argument as required by 37 C.F.R. § 42.70(b).

This filing is timely, being submitted no later than DUE DATE 4 (May 1, 2017), according to the Scheduling Order.
