**PATENT OWNER'S REQUEST FOR ORAL ARGUMENT**  
**37 C.F.R. § 42.70(a)**

Pursuant to 37 C.F.R. § 42.70(a) and the Scheduling Order issued on October 19, 2016, Paper 13 (the “Scheduling Order”), Patent Owner, UUSI, LLC d/b/a/ Nartron (“Nartron”) hereby requests oral argument for the hearing currently scheduled for June 22, 2017.<sup>1</sup> Nartron respectfully requests one hour per side of oral argument time on the following issues:

- (1) The grounds on which the subject trial was instituted;
- (2) Whether a person of ordinary skill in the art would have been motivated to combine the alleged prior art;
- (3) Whether a person of ordinary skill in the art would have had a reasonable expectation of success in practicing the challenged claims;
- (4) Motions to exclude filed in this proceeding (if any); and
- (5) Any other matters raised by Petitioner or the Board.

Nartron requests the ability to use audio-visual equipment to display demonstrative exhibits, including the use of a projector and screen for PowerPoint display. In accordance with the Office Patent Trial Practice Guide, 77 Fed. Reg. 48756, 48768 (Aug. 14, 2012), Nartron will contact a Board Trial Division paralegal to discuss this request.
