## Petitioner's Objections to Patent Owner Demonstratives

As indicated in the Order, the parties have met and conferred on their respective Demonstratives. Petitioner has the following objections that remain unresolved between the parties:

Slides 5, 14, 20, 21, and 43 – each slide contains a picture of the expert witness. None of these pictures are part of any exhibit or paper, nor were they ever introduced into the record in this proceeding.

Slide 17 – the phrases "Preamble informs" and "Specification describes a specific function" in the first two bullets on this slide represent new arguments not raised in the Patent Owner Response, and neither is correct with respect to the relevant law of claim construction. Petitioner has considered the approach suggested in the *St. Jude Medical* case cited in the Order regarding each side agreeing to expunge the Demonstrative Exhibits after the oral hearing, but Petitioner is not willing to agree to any such expungement of the record.
