PATENT OWNER'S REQUEST FOR ORAL ARGUMENT

Pursuant to the Board's November 2, 2016 Scheduling Order (Paper 8) , the Board's January 17, 2017 Amended Scheduling Order (Paper 18), and the May 19, 2017 conference call between the Board and parties, Patent Owner respectfully requests oral argument. Pursuant to the Board's instruction during the May 19, 2017 call, the parties have conferred to determine their available dates in late July and August for the Oral Argument. Petitioner has indicated that it is available on August 15-18, 2017 for Oral Argument, and Patent Owner is also available on those dates. As authorized during the May 19 call, backup counsel for Patent Owner is prepared to conduct the Oral Argument in the event that the Oral Argument cannot be rescheduled.

Pursuant to 37 C.F.R. § 42.70, Patent Owner specifies the following issues to be argued:

- Claims 4, 5, 7–11, 14, and 19 are not anticipated under 35 U.S.C. § 102 by Karol;
- Claims 4, 5, 7–15, and 19 are not unpatentable under 35 U.S.C. § 103(a) over the teachings of Karol; and
- Claims 5, 11–15, and 19 are not unpatentable under 35 U.S.C. § 103(a) over the teachings of Karol and Stallings.
