**EXCLUSIVE LICENSEE FATPIPE, INC.'S OBJECTIONS TO
PETITIONER'S EVIDENCE IN A PRELIMINARY PROCEEDING
UNDER 37 C.F.R. § 42.64(b)(1)**

Pursuant to 37 C.F.R. § 42.64(b)(1), Exclusive Licensee, FatPipe, Inc., hereby timely objects to the evidence submitted by Petitioner, Talari Networks, Inc., with the Petition for Inter Partes Review (Paper 1) filed April 29, 2016. The objections are made based on rules under 37 C.F.R. Part 42 on IPR proceedings and relevant portions of Federal Rules of Evidence (“FRE”) that are applicable to IPR proceedings under 37 C.F.R. § 42.62.

1. Patent Owner objects to Exhibit 1011 (William Stallings, “Data and Computer Communications”) and it should be excluded for at least the following reasons: the exhibit lacks authentication under FRE 901, 902, and 903; the exhibit is not relevant under FRE 402 and confuses the issues and wastes time under FRE 403. Petitioner has purported that Exhibit 1011 bears a prior art qualifying date of 1997. Exhibit 1011, however, was published in April of 2001.

These objections have been timely filed and served within TEN business days of the institution of the trial.
