In September 2004, I reviewed a retail version of the HP iPAQ RX3115. The HP iPAQ RX3115 was in retail packaging, which included a manual with operating instructions.

- 10. After I obtained the HP iPAQ RX3115 to write my review, I reviewed the manual to learn how to operate the camera and to learn about the technical features of the HP iPAQ RX3115.
- 11. I posted my HP iPAQ RX3115 review on pdabuyersguide.com on September 10, 2004 at http://www.pdabuyersguide.com/iPAQ rx3115.htm.
- 12. My review of the HP iPAQ RX3115 was made available to the public by posting on the www.pdabuyersguide.com web site on September 10, 2004 and members of the public read my review of the product shortly thereafter.
- 13. When the domain was transitioned from pdabuyersguide.com to MobileTechReview.com in 2005, my review of the HP iPAQ RX3115 was transferred to the new web site. The review is still available on-line at http://www.mobiletechreview.com/iPAQ rx3115.htm.

- 16. I examined Attachment C attached to my Declaration. I recognize Attachment C as another copy of the HP iPAQ RX3115 manual I read in September 2004 in order to prepare my review of the HP iPAQ RX3115 PDA, which was posted on September 10, 2004 on the pdabuyersguide.com web site.
- 17. My review on pdabuyersguide.com described the same features as the manual in Attachment C. In my review, I wrote: "The manual says that streamed WMV files must be formatted specifically for the iPAQ in order to playback, but gives no information on what that means exactly." The manual in Attachment C states on page 6-74: "However, your HP iPAQ will only play .wmv files that were specifically created for handheld devices."
- 18.
