 A composition suitable for injection through a need into a host, comprising:

microparticles comprising a polymeric binder; and an injection vehicle, wherein said microparticles are su pended in said injection vehicle at a concentration greater than about 30 mg/ml to form a suspension wherein a fluid phase of said suspension has a viscosi greater than about 20 cp and less than about 600 cp 20° C., wherein the viscosity of said fluid phase of sa suspension provides injectability of the composition through a needle ranging in diameter from 18–2 gauge.
