2 HON. FRANKLIN: This is a
3 conference call for cases
4 IPR2016-0111, 1112 and 1113. With me
5 on the call are two other panel judges
6 for cases 1111 and 1112, Judges Hulse
7 and Paulraj. Also with me on the call
8 are two of the panel judges for case
