Use Xiidra twice per day

Use one drop of Xiidra in each eye, two times a day, about 12 hours apart.



Wear contact lenses?

Take 'em out before using Xiidra and wait at least 15 minutes before popping them back in.



Single-dose containers

Each Xiidra container has enough medicine to treat both of your eyes once. So you'll be using two



Scrub those hands

To avoid contamination, wash your hands first & don't let the tip of the container touch your eye or any surface.

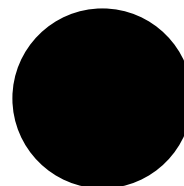
Have bad aim? It's ok!

Select Important Safety Information

If you wear contact lenses, remove them before using Xiidra and wait for at least 15 minutes before placing them back in your eyes.
