The word-for-word identical paper is filed in each proceeding identified in the caption pursuant to the Board's Scheduling Order (Paper 10).

I, Dale White, declare as follows:

1. I am more than twenty-one years of age, competent to present this affidavit, and have personal knowledge of the facts set forth herein.

2. This declaration is given in support of Patent Owner's Motion to Seal.

3. I am General Counsel for the Saint Regis Mohawk Tribe.

4. Exhibit 2086 and Exhibit 2087 are the Long-Form Patent Assignment Agreement and License Agreement entered between the Saint Regis Mohawk Tribe and Allergan on September 8, 2017,

5. These agreements both contain confidential business information that would undermine the Tribe's competitive standing in future license negotiations if the terms were made public.

6. Both Agreements also contain Confidentiality and Non-Disclosure Clauses.

7. Because of their confidential nature, both of these documents were made exempt from disclosure under Section 1.9-2(b) of the Saint Regis Mohawk Tribe Open Records Policy and Section XI.3.(b) of the Saint Regis Mohawk Tribal Counsel Procedures Act of 2013 in Tribal Council Resolution 2017-58 that was passed on September 8, 2017.

8. The Tribe has endeavored to redact as little information as possible from the documents to strike a balance between the strong public policy that favors making

information filed in an *inter partes* review open to the public and the confidential nature of the information contained in these documents.

9. To that end, only confidential information that was not cited by any of the parties in the Motion to Dismiss briefing has been redacted.

10. I hereby declare that all statements made herein of my own knowledge are true and further that all statements herein are made with knowledge that willful false statements and the like are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code.
