PETITIONERS' REQUEST FOR ORAL HEARING

In accordance with 37 C.F.R. § 42.70(a), Petitioners HTC Corporation, HTC America, Inc., and Apple Inc. hereby request an oral hearing in the present *inter partes* review. The issues to be argued include:

1. The combination of Bowes, TMS and Thomas renders obvious each and every element of claims 1-5 and 12-14 including a “shared bus” having sufficient bandwidth to enable a decoder to access the memory and operate in real time when another device simultaneously accesses the bus;
2. The combination of Bowes, TMS, Thomas, and Gove renders obvious each and every element of claims 6 and 8;
3. The combination of Bowes, TMS, Thomas, and Ran renders obvious each and every element of claim 7;
4. The combination of Bowes, TMS, Thomas, and Celi renders obvious each and every element of claim 11; and
5. Other issues raised in papers filed in the present proceeding, including issues raised in any papers filed between today and the oral hearing.

In light of these remarks, Petitioners respectfully request the opportunity to present oral arguments before the Board on September 5, 2017. *See* Order, Paper No. 14 at 3; *see also* Scheduling Order, Paper No. 8 at 5, 8.

Petitioners request that the oral hearings for IPR2016-01114, IPR2016-01121, and IPR2016-01135 be conducted seriatim. Petitioners also request that each side be allocated a total of 20 minutes to present oral arguments for each of IPR2016-01121 and IPR2016-01135 and 30 minutes to present oral arguments for IPR2016-01114. Petitioners have conferred with Patent Owner's counsel regarding the duration for each proceeding and have not come to an agreement.
