AS BUSINESS CONFIDENTIAL INFORMATION AND TO KEEP  
SEPARATE PURSUANT TO 35 U.S.C. § 317(b) AND 37 C.F.R § 42.74(c)**

Microsoft Mobile Inc. and Microsoft Corporation (“Microsoft”) and Patent Owner FastVDO LLC (“FastVDO”) jointly request that the Board treat the contemporaneously filed Settlement And Release Agreement between Microsoft and FastVDO (Ex. 1015) (“the Agreement”) as confidential, keep it separate from the files of the involved patent and this proceeding, and not disclose its contents to anyone outside of the Board. The Agreement includes business confidential information of Microsoft and Patent Owner FastVDO LLC. Accordingly, disclosure of the information would cause irreparable harm to these parties.
