I, Scott Bennett, hereby declare as follows:

## I. PROFESSIONAL BACKGROUND AND QUALIFICATIONS

1. I make this declaration based on my personal knowledge, consideration of the materials I discuss herein, and my expert opinions.

 I am a retired academic librarian working as a Managing Partner in Prior Art Documentation Services LLP, at 711 South Race Street, Urbana, IL, 61801-4132. I have over 27 years of research librarian experience.

3. From 1974-1981, I was employed as an Instructor, Assistant, and Associate Professor of Library Administration at the University of Illinois at Urbana-Champaign, Urbana, IL.

From 1981-1989, I was employed as the Assistant University
 Librarian for Collection Management at Northwestern University, Evanston, IL.

From 1989-1994, I was employed as the Director of the Milton S.
 Eisenhower Library at the Johns Hopkins University, Baltimore, MD.

6. From 1994-2001, I was employed as the University Librarian at Yale University, New Haven, CT.

7. I received an A.B. in English from Oberlin College (1960), a Ph.D. in English from Indiana University (1967), and an M.A. in Library Science from the University of Illinois (1976) 8. Additional details of my education and experience are set forth in my curriculum vitae, a copy of which is attached as Exhibit 10028. ## II. SCOPE OF THIS REPORT

11. My compensation for time spent working on this matter is based on a rate of \$85 per hour. This compensation is not contingent on my opinions, my performance or the outcome of the *inter partes* review, or any issues in or related to this *inter partes* review.

### IV. INTRODUCTORY INFORMATION

12. *Library catalog records.* Libraries world-wide use the MARC format for catalog records; this format was developed at the Library of Congress in the 1960s. WorldCat is the world's largest public online catalog (see <a href="https://en.wikipedia.org/wiki/OCLC">https://en.wikipedia.org/wiki/OCLC</a> ). Its records appear in many different catalogs, including the Statewide Illinois Library Catalog.

13. *Library management of periodicals.* For periodical publications, a library will typically create a catalog record for the periodical when the library orders or receives its first issue. When the institution receives subsequent issues/volumes of the periodical, the issues/volumes are checked in (often using a date stamp), added to the institution's holdings records, and made publicly accessible very soon thereafter—normally within a few days of receipt or (at most) within a few weeks of receipt.

14. *Indexing.* An ordinarily skilled researcher will typically begin his or her search for relevant information in an index of periodical and other publications.

Having found relevant material, the researcher will then obtain it online, look for it in libraries, or purchase it from the publisher, a bookstore, or other provider.

## V. DOCUMENTS REPRESENTED AS PRIOR ART

## A. Rusthoven

## 1. Authentication

15. *Rusthoven* is a research paper published in the *Journal of Clinical Oncology*, an online copy of which is available from Cadmus ArticleWorks (Ex.
1030). Ex. 1031 is the relevant entry from University of Illinois at UrbanaChampaign Library directory to electronic journals.

## 2. Public accessibility

16. *Rusthoven* was published in the *Journal of Clinical Oncology*, which is held by 798 libraries world-wide, as indicated in the Statewide Illinois Library Catalog record for this journal (Ex. 1032). Ex. 1033 is a copy of *Rusthoven*, and of the cover and relevant table of contents for the *Journal of Clinical Oncology*, from the University of Illinois at Chicago Library. A somewhat difficult to read date stamp (Ex. 1033 at 9) shows that *Rusthoven* was processed at that library in April 1999 and was therefore publicly accessible soon thereafter.

17. *Rusthoven* was indexed in the widely used Web of Science abstracting and indexing service (Ex. 1034).
