Members of the Board,

Petitioner Apple requests authorization from the Board to file a Motion for Entry of Judgment In Favor Of Petitioner As A Sanction For *Ex Parte* Communications and As A Remedy For Due Process Violations, Or, Alternatively, For “Entirely New” and “Constitutionally Correct” Proceedings. Apple’s motion relates to improper *ex parte* communications (attached) directed to the Board and to the specific panels of the Board adjudicating this proceeding and the impacts thereof on Petitioner’s Due Process rights.

While there is no specific deadline for such a motion, we believe it would need to be filed by next Wednesday, December 20, the deadline for Motions for Reconsideration. Apple has conferred with Voip-Pal and both parties are available at any time on December 19 or December 20 for a call with the Board.
