On June 22, 2016, Argentum Pharmaceuticals LLC (“Argentum”) filed a Petition for *Inter Partes* review (“IPR2016-01232”) concerning U.S. Patent No. 8,629,111 (“the ’111 patent”). Paper 2. The parties agreed to settle the dispute, and on December 7, 2016 the parties filed a Joint Motion to Terminate the *Inter Partes* Review. Paper 10. The Board granted the Motion on December 8, 2016. Paper 14.

In accordance with 37 C.F.R. § 42.15(a)(2), the post-institution fees were paid at the time of filing. Because IPR2016-01232 was terminated prior to institution, Argentum respectfully requests a refund of the \$18,800 post-institution fees. Refund of the post-institution fees is proper when the proceeding is terminated prior to a decision to institute. 78 Fed. Reg. 4212, 4233 (Jan. 18, 2013); *Fifth Third Bank v. Leon Stambler*, IPR2014-00244, Paper 11, at 2 (August 12, 2014).
