Conduct of the Proceeding

A conference call in the above proceeding was held on June 5, 2017, among respective counsel for Petitioner and Patent Owner, and Judges Arbes, Fitzpatrick, and Chagnon. The call was requested by Patent Owner to seek authorization to file a corrected version of the declaration of E. Fred Schubert, Ph.D., submitted by Patent Owner with its Response on March 24, 2017 (Ex. 2012). Patent Owner explained during the call that the proposed corrections were discussed during Dr. Schubert's deposition and would correct four alleged typographical errors in paragraphs 236 (replacing "Noble" with "Lee"), 275 (removing "(e.g. by CMP)"), 415 (removing "(e.g. by CMP)"), and 427 (replacing "Noble" with "Noble/Ogawa"). Petitioner did not oppose Patent Owner's request. After hearing from the parties, and given the minor nature of the proposed changes, we determined that Patent Owner had shown sufficient reason for filing the corrected declaration. *See* 37 C.F.R. § 42.5(a).

In consideration of the foregoing, it is hereby:

ORDERED that Patent Owner shall file, by June 8, 2017, a corrected version of Dr. Schubert's declaration, making only the handwritten changes discussed during the call, as Exhibit 2012, after which the original version of Exhibit 2012 will be expunged from the record of this proceeding.
