- the Board's determination that Patent Owner's proposed claim 13 is patentable under 35 U.S.C. § 103 over (i) U.S. Patent No. 6,887,353 ("Ding") and U.S. Patent No. 5,893,752 ("Zhang"), and (ii) Ding, Zhang, and U.S. Patent No. 6,346,745 ("Nogami"); and
