Pursuant to 37 CFR 42.123 and in accordance with footnote 2 of Paper Nos. 21 (IPR2016-01259), 18 (IPR2016-01261), 18 (IPR2016-01262), and 24 (IPR2016-01263), Petitioners seek the Board's authorization to file a motion to submit previously-expunged Exhibit Nos. 1153 (IPR2016-01259), 1054 (IPR2016-01261), 1054 (IPR2016-01262), and 1053 (IPR2016-01263) as supplemental evidence in IPR2016-01259, IPR2016-01261, IPR2016-01262, and IPR2016-01263. Petitioners believe that the information contained in the exhibits—namely Petitioners' expert's rebuttal opinions regarding how a person of ordinary skill in the art would understand the "switching facility" claim terms—is relevant to the construction of the "switching facility" terms in these cases. Following a meet and confer, Patent Owner has indicated that it opposes Petitioners' request.
