Slide 14 contains new arguments because Patent Owner only cited to Exhibit 1004, 3:62-64 in its Patent Owner Response, but copies a larger disclosure from 3:62-67 (including an additional sentence not previously relied upon) in this slide.

Slide 9 contains new arguments because Patent Owner only cited to Exhibit 1004, 9:47 in its Patent Owner Responses, but copies a larger disclosure from 9:47-50 in this slide.

Patent Owner objects to Petitioner's **slides 16, 30, 31, 35, 38, 39, 51, 50 and 64** for the reasons set forth below:

Slides 35 and 51 refer to new evidence Ex.1033 in its Replies to support its case-in-chief, and neither exhibit is cited in the Petitions or Responses. These exhibits should be limited to the Contingent Motion to Amend.

Slides 38 and 64 refer to new evidence Ex.2042 in its Replies to support its case-in-chief, and neither exhibit is cited in the Petitions or Responses. These exhibits should be limited to the Contingent Motion to Amend.

Slides 16, 30, 31, 39 and 50 are objected to for referring to new arguments and/or new evidence not raised or cited in the Petitions.
