## Notice of Stipulation – Modification of Due Dates 1 and 2

Patent Owner OSI Pharmaceuticals, LLC, the successor in interest to OSI Pharmaceuticals, Inc., and Petitioners Apotex Inc., Apotex Corp., Apotex Pharmaceuticals Holdings Inc., and Apotex Holdings, Inc., by and through their respective counsel of record, have stipulated as follows:
