Petitioner Nu Mark LLC (“Petitioner”) requests a refund of post-institution fees in the amount of \$14,000.00.

On June 28, 2016, Petitioner filed a Petition for *Inter Partes* review of U.S. Patent No. 8,365,742. As required by 37 C.F.R. § 42.15(a), Petitioner deposited \$23,000.00 with the U.S. Patent and Trademark Office (“USPTO”) at the time of filing the Petition to cover associated fees. Petitioner’s payment consisted of \$9,000.00 in fees associated with the request for *Inter Partes* review, \$14,000.00 in post-institution fees.

On January 3, 2017, a Joint Motion to Terminate the Proceeding was filed (Paper 9). On January 4, 2017, the Board granted the Joint Motion and terminated the proceeding. *Inter Partes* review was thus not instituted. Accordingly, Petitioner requests a refund of the post-institution fees paid to the USPTO in connection with this proceeding, totaling \$14,000.00, to be paid to deposit account number 506499.
