Pursuant to 37 C.F.R. § 42.10 (c) and the Notice of Filing Date Accorded to Petition and Time for Filing Patent Owner Preliminary Response entered on August 9, 2016 (Paper 6) in this proceeding, Petitioner respectfully requests the expedited pro hac vice admission of Charles M. Stiernberg in this proceeding as counsel for Samsung Electronics Co., Ltd. and Samsung Electronics America, Inc. ("Samsung"). Mr. Stiernberg is an experienced patent litigation attorney, with more than three years of experience, including involvement in fact and expert discovery, Markman briefing and hearings, and oral arguments in patent infringement matters before Federal district courts in Delaware, Texas, and California. U.S. Patent No. 8,218,481 is involved in parallel litigation filed by Patent Owner against Samsung in the United States District Court for the District of Delaware (Civil Action No. 15-cv-545-SLR). Mr. Stiernberg has appeared as counsel for Samsung in this litigation and is actively involved in all aspects of the district court proceedings. (Id.). Therefore, good cause exists to admit Mr. Stiernberg pro hac vice in this proceeding. Further, in view of an upcoming teleconference with the Board, currently scheduled for Monday, December 19, 2016 at 12:30 PM ET, Samsung respectfully requests an expedited decision on this Motion.
