1. I am a patent specialist of General Plastic Industrial Co., Ltd. (“GPI”). 7. On May 3, 2016, I found Japanese Patent Application Publication No. 2000-305346 to Suzuki (“Suzuki”) through a search on Japan Platform for Patent Information web database (<https://www.j-platpat.inpit.go.jp/>). On June 3, 2016, I sent Suzuki to Locke Lord LLP via email.
8. GPI had no knowledge of Koide, Yasuda, or Suzuki prior to May 3, 2016.
