**PATENT OWNER REALTIME DATA, LLC D/B/A IXO'S  
REQUEST FOR ORAL ARGUMENT**

Pursuant to 37 C.F.R. § 42.70, the Scheduling Order (Paper 12) setting Oral Argument for September 20, 2017, Patent Owner Realtime Data, LLC d/b/a IXO hereby request that the Patent Trial and Appeal Board hear oral argument on the following issues:

- 1) Whether Petitioner Apple Inc. has met its burden of proving claims 1-31 of U.S. Patent No. 7,181,608 (“the ‘608 Patent”) are unpatentable under 35 U.S.C. § 103(a) over U.S. Patent No. 5,860,083 (“Sukegawa”) and U.S. Patent No. 6,145,069 (“Dye”);
- 2) Whether Petitioner Apple Inc. has met its burden of proving claims 1-6 and 9-17 of the ‘608 Patent are unpatentable under 35 U.S.C. § 103(a) in view of Sukegawa, Dye, and U.S. Patent No. 6,374,353 (“Settsu”);
- 3) Whether Petitioner Apple Inc. has met its burden of proving claims 1–6 and 9-17 of the ‘608 Patent are unpatentable under 35 U.S.C. § 103(a) in view of Sukegawa, Dye, and Michael Burrows et al., On-line Data Compression in a Log-structured File System (1992) (“Burrows”);
- 4) Whether Petitioner Apple Inc. has met its burden of proving claims 1–6 and 9-17 of the ‘608 Patent are unpatentable under 35 U.S.C. § 103(a) in view of Sukegawa, Dye, Settsu, and Burrows;

- 5) Any subsidiary issue relevant to issues (1) to (4), including, without limitation, claim construction, assessment of evidence, and admissibility of evidence; and
- 6) Any other issues the Board deems necessary for issuing a final written decision.
