**Petitioner objects to Patent Owner’s slides 9–20, 23, 36, and 38** because they falsely portray a factual dispute over the application of a claim construction as a dispute over the claim construction itself. Petitioner further objects to Patent Owner’s **slides 14, 17, 21–23, 36, 38, 41, and 51** because they misrepresent Dr. Smith’s testimony by using incomplete testimony, taking his testimony out of context, mischaracterizing it as inconsistent, and/or imputing false significance to it. Petitioner also objects to Patent Owner’s **slides 14–17, 22, 36, 38, 41, 43, 44, 51, and 57** because they present new arguments not presented in the Patent Owner’s Response, only in improperly argumentative “observations” regarding Dr. Smith’s cross-examination testimony.

**Patent Owner** maintains its scope objections (Pap. 36) and objects to the new arguments/cites in Petitioner’s slides: **5** (reliance on EX1039-EX1040 for this point), **18-25** (re shifting production burden; improper reliance on Reply to Prelim. Resp.), **86** (same), **147** (same), **36** (thickness of 355, 353; EX2040 57:22-59:19), **41** (EX1047 95:4-96:21), **45** (fourth bullet), **47** (bullet), **49** (reliance on EX1006, EX1011 for this point), **64** (bullet), **66** (second bullet on left and parenthetical in second bullet on right), **68** (three blue bullets), **75** (“No Thinning of Layer 68,” Figs. 6E-6F), **80** (assertion that layer 58 is “equivalent” to layer 45), **86** (right column—see 8/18/17 email to Board), **159-160** (entire slides), **162** (header), **165-166** (citation to references 51-56), **172** (entire slide), **178** (Smith Tr. 27:8-12).
