1. The construction of relevant claim terms of U.S. 8,773,356 (the “’356 patent”);
2. The patentability of claims 1-3, 5, 7, 9-13, 15, 17, 19-23, 25, and 26 of the ’356 patent in view of the references relied upon in the Petition;
3. The parties’ motions to exclude;
4. Respond to any issues specified by Petitioner in its request for oral argument or otherwise presented by the Petitioner; and
5. Any additional issues on which the Board seeks clarification.

Immersion understands that oral argument will be held on October 5, 2017. Scheduling Order, Paper 8. Concurrently with this filing, Immersion is also requesting an oral hearing in IPR2016-01372, which is scheduled for the same day and before the same Board. Immersion respectfully requests that the oral hearing for this matter and for IPR2016-01372 be scheduled consecutively on October 5, 2017.

Immersion requests the ability to use audio/visual equipment to display demonstrative exhibits, including the use of a projector and screen for a

PowerPoint display. In accordance with the Trial Practice Guide, 77 Fed. Reg. at 48768, Immersion will contact the Board Trial Division paralegal to discuss this request.
