On June 27, 2017, Petitioner filed a Motion to Withdraw Counsel in each of the above-identified proceedings, requesting that its back-up counsel, Yasser Mourtada, be permitted to withdraw as counsel of record for Petitioner in these proceedings. Paper 18, 1.<sup>2</sup> Petitioner represents that Patent Owner does not oppose the Motions. *Id.*

After due consideration, Petitioner's Motions are granted.

#### ORDER

Accordingly, it is ORDERED that Petitioner's Motions to Withdraw Counsel are *granted*;

FURTHER ORDERED that Yasser Mourtada is withdrawn as counsel of record for Petitioner in each of the above-identified proceedings; and

FURTHER ORDERED that Petitioner shall file updated mandatory notices under 37 C.F.R. § 42.8(b) in the above-identified proceedings, providing updated counsel and service information.
