Pursuant to 37 C.F.R. § 42.70 and the Board's April 17, 2017 Scheduling Order (Paper 14) and the Notice of Stipulation to Move Due Dates (Paper 16), Petitioner Apple Inc. respectfully requests oral argument, which is currently scheduled for January 16, 2018, on the issues raised in the Petition for *Inter Partes* Review of U.S. Patent No. 6,470,399 ("the '399 patent"), Patent Owner's Preliminary Response, Patent Owner's Response, Petitioner's Reply to Patent Owner's Response, Patent Owner's Motion for Observations on Cross Examination and Petitioner's Response to Patent Owner's Motion for Observations.
