The cases identified above were dismissed and are no longer pending.

Toyota is not aware of any administrative matters that would affect, or be affected by, a decision in this proceeding.

Toyota notes that Petitioner has previously filed a petition for *inter partes* review of another patent assigned to Toyota, U.S. Patent No. 8,324,295 B2. That petition is pending in IPR2016-01462.
