Petitioner requests (without waiving consideration of any issue not listed below) to address the following issues:

1. The unpatentability of claims 1–4 and 6 of U.S. Patent No. 6,700,602 under 35 U.S.C. § 103 over Namikawa, Sasao, Amano, and Maekawa;
2. Petitioner’s motion to exclude evidence;
3. Any motion to exclude evidence by Patent Owner;
4. Patent Owner’s Observations on Lowell Malo’s November 28, 2017 Deposition, and Petitioner’s Response to the Observations;
5. Rebuttal to Patent Owner’s presentation on all matters; and
6. Any additional issues on which the Board seeks clarification.

Petitioner requests no more than one hour per side of oral argument time.

Petitioner also respectfully requests the ability to use audio visual equipment to display demonstrative exhibits, including the use of a projector and screen that may be connected to a laptop computer of Petitioner’s counsel.
