

As you know, we represent Ironburg Inventions, an IP Company that licenses gaming technology to Scuf Gaming, which makes and sells tactical gear for elite gamers.

In prior correspondence with and in the pending litigation against your client Valve Corporation, Ironburg has:

- (i) identified its ownership of patents and pending patent applications directed to gaming controllers, including now issued U.S. Patent Nos. 8,641,525 (the '525 patent) issued on 4 February 2014; 9,089,770 (the '770 patent) issued on 28 July 2015; and 9,289,688 (the '688 patent) issued on 22 March 2016; and
- (ii) notified Valve that certain game controllers sold by Valve, including the Steam Controller, infringe the above-identified patents.

Despite multiple notifications of infringement, it is our understanding that Valve continues to make, market and/or sell infringing Valve controllers.
