ORDER
Granting Admission *Pro Hac Vice*

It is

ORDERED that Patent Owner's Motion for Admission *Pro Hac Vice* of Kayvan B. Noroozi is granted;

FURTHER ORDERED that Mr. Noroozi is authorized to appear as back-up counsel for Patent Owner in the above proceeding, but he may not act as lead counsel;

FURTHER ORDERED that a registered practitioner must remain as lead counsel throughout the proceedings;

FURTHER ORDERED that Mr. Noroozi is to comply with the Office Trial Practice Guide and the Board's Rules of Practice for Trials set forth in Title 37, Part 42 of the Code of Federal Regulations; and
