these cases. Patent Owner represented that, among other conflicts, Patent Owner's lead counsel will be out of the country on that date. Patent Owner further represented that Petitioner does not oppose Patent Owner's request to change DUE DATE 7. After a series of email exchanges with the Board, both parties indicated that they are available for oral argument on April 19, 2018.

Under these circumstances, we find good cause to grant Patent Owner's request to change the date of oral argument in these cases. *See* 37 C.F.R. § 42.5(c).

Accordingly, it is

ORDERED that DUE DATE 7, the date for oral argument in these cases, is changed to April 19, 2018.
