Accordingly, Exhibit 1012 is expunged from the record in each case. Within one week of the date of this order, Petitioner shall file an updated, complete version of Exhibit 1012 that includes all pages relied upon in the Petition and Dr. Forys's Declaration. In addition, Petitioner shall confirm that no other exhibits have missing pages or other deficiencies and shall notify the Board by e-mail to [trials@uspto.gov](mailto:trials@uspto.gov) if any other exhibits contain any deficiencies.

#### ORDER

Accordingly, it is:

ORDERED that Exhibit 1012 is expunged from the record in IPR2017-00220 and IPR2017-00221; and

FURTHER ORDERED that within one week of the date of this order, Petitioner shall file a complete version of Exhibit 1012 and shall notify the Board by e-mail to [trials@uspto.gov](mailto:trials@uspto.gov) if any other exhibits contain deficiencies.
