As authorized by the Board in e-mail correspondence of February 28, 2018, counsel for Patent Owner, Daniel L. Flamm, filed in each proceeding, Patent Owner's Unopposed Motion for Withdrawal and Substitution of Counsel. Paper 20 ("Motion").<sup>3</sup> Patent Owner previously appointed Christopher Frerking as lead counsel. Paper 6.
