DECISION

Granting Motion to Terminate 37 C.F.R. §§ 42.5(a) and 42.71(a)

and

Granting Request to Treat Settlement Documents as Confidential Business Information 37 C.F.R. § 42.74(c)



On February 16, 2017, the parties filed a Joint Motion to Terminate Proceeding (Paper 8), a Joint Request to Treat Settlement Documents as Business Confidential Information (Paper 9), a Settlement Agreement (Paper 10), and a redacted copy of the Settlement Agreement (Paper 11) as papers to this proceeding. The Joint Request to Treat Settlement Documents as Business Confidential Information referred to several documents that were not then filed in this proceeding, including a Letter Agreement and a Term Sheet. Paper 9, 1.

The Board ordered the parties to refile the Joint Motion to Terminate and Joint Request to Treat Settlement Documents as Business Confidential Information as papers to this proceeding, and to file only true, unredacted, copies of the Settlement Agreement, Letter Agreement, and Term Sheet as exhibits to this proceeding. Paper 12, 3–4. The Board indicated that upon the refiling of these papers and exhibits, the Board would expunge from the record the originally filed Joint Motion to Terminate (Paper 8), Joint Request to Treat Settlement Documents as Confidential Business Information (Paper 9), Settlement Agreement (Paper 10), and redacted Settlement Agreement (Paper 11).

On February 24, 2017, the parties refiled the Joint Motion to Terminate Proceeding (Paper 13) and Joint Request to Treat Settlement Documents as Confidential Business Information (Paper 14). The Joint Motion to Terminate requests termination of this proceeding because the parties have settled their dispute regarding U.S. Patent No. 7,752,650 ("the '650 patent") and related patents. Paper 13, 1–4. The parties concurrently filed a true copy of their Settlement Agreement, including an accompanying

Letter Agreement and Term Sheet, as exhibits in this proceeding. *Id.*; *see also* Exs. 1035–1037.

This proceeding is at an early stage. Petitioner filed a Petition for *Inter Partes* Review of claims 1, 2, 4, 18, 32, and 33 of the '650 patent on November 18, 2016. Paper 2. Patent Owner has yet to file a Preliminary Response, and we have neither considered the merits of the Petition nor decided whether to institute trial.

Under the foregoing circumstances, we determine it is appropriate to dismiss the Petition. *See* 37 C.F.R. §§ 42.5(a), 42.71(a). We also determine it is appropriate to treat the parties' Settlement Agreement (Ex. 1035), Letter Agreement (Ex. 1036), and Term Sheet (Ex. 1037) as confidential business information, and to keep these documents separate from the files of the '650 patent.

This paper does not constitute a final written decision pursuant to 35 U.S.C. § 318(a).

Accordingly, it is hereby:

ORDERED that the Joint Motion to Terminate the Proceeding (Paper 13) is granted;

FURTHER ORDERED that the Petition for *Inter Partes* Review of U.S. Patent No. 7,752,650 is dismissed;

FURTHER ORDERED that the Joint Request to Treat Settlement Documents as Confidential Business Information (Paper 14) is granted;

FURTHER ORDERED that Exhibit 1035 ("Settlement Agreement") be maintained as confidential business information and kept separate from the files of U.S. Patent No. 7,752,650;

FURTHER ORDERED that Exhibit 1036 ("Letter Agreement") be maintained as confidential business information and kept separate from the files of U.S. Patent No. 7,752,650;

FURTHER ORDERED that Exhibit 1037 ("Term Sheet") be maintained as confidential business information and kept separate from the files of U.S. Patent No. 7,752,650;

FURTHER ORDERED that Paper 8 ("Joint Motion to Terminate Proceeding") be expunged from the record;

FURTHER ORDERED that Paper 9 ("Joint Request to Treat Settlement Documents as Confidential Business Information") be expunged from the record;

FURTHER ORDERED that Paper 10 ("Settlement Agreement") be expunged from the record; and

FURTHER ORDERED that Paper 11 ("Redacted Settlement Agreement") be expunged from the record.
