PETITIONER'S REQUEST FOR ORAL ARGUMENT

Petitioner Samsung Electronics Co., Ltd. and Samsung Electronics America Inc. Pursuant to 37 C.F.R. § 42.70, Petitioner specifies the following issues to be argued:

- Grounds for which *inter partes* review was instituted for the ’134 Patent and any issue raised in the Board’s Institution Decision;
- Any issue addressed in Petitioner’s papers, including but not limited to the Petition and Petitioner’s Reply Brief;
- Rebuttal to Patent Owner’s presentation on all issues, including the issues identified above and any issues raised in Patent Owner’s Response and exhibits cited therein.
- Any issues raised by the Board or Patent Owner at oral argument;
- Any other issues raised in papers filed in this proceeding, including issues raised in papers yet to be filed; and
- Any other issues that the Board deems necessary for issuing a final written decision.

Pursuant to the Scheduling Order (Paper 13 at 4, 6) the oral hearing for this case IPR2017-00353 is currently scheduled for February 21, 2018. Petitioner requests half of the time that the Board determines is appropriate for oral argument and expressly reserves the right to use a portion of its time for rebuttal. Petitioner

additionally requests that the Board provide audio-visual equipment to display demonstrative exhibits, including a monitor or projector to be connected to a laptop, a screen, and an ELMO for displaying documents of record.
