The Board authorized the filing of a motion seeking to terminate this proceeding on June 29, 2017. Accordingly, pursuant to 35 U.S.C. § 317(a), Petitioner PayPal, Inc. (“Petitioner”) requests termination of this *inter partes* review proceeding involving U.S. Patent No. 8,712,918 (“the ’918 Patent”). Patent Owner MoneyCat LTD. (“Patent Owner”) consents to, and joins, this request for termination.

Petitioner believes that termination is appropriate because the parties have resolved their dispute with respect to the ’918 Patent. Further, there is no other pending proceeding involving the ’918 Patent.
