8. I am a partner at Pepper Hamilton LLP and am an experienced intellectual property litigation attorney, with substantial experience in complex patent litigation in various federal courts. I am particularly familiar with the subject matter at issue in this proceeding, including the patent at issue (U.S. Patent No. 6,363,345) and the prior art upon which Petitioner relies, due to my representation of Patent Owner before the United States International Trade Commission (*In re Certain Audio Processing Hardware, Software, and Products Containing the Same*, Inv. No. 337-TA-1026) and in the two pending district court cases involving the patent at issue (*Andrea Elecs. Corp. v. Apple Inc.*, United States District Court, Eastern District of New York, Civil Action No. 2-16-cv-05220; *Andrea Elecs. Corp. v. Samsung Elec. Co., Ltd. et al.*, United States District

Court, Eastern District of New York, Civil Action No. 2-16-cv-05217. I have reviewed the entire record of the instant proceeding and am well acquainted with the underlying legal and technological issues in the these proceedings.
