PETITIONER'S REQUEST FOR ORAL ARGUMENT

(“Viptela”), by counsel, submits this Request for Oral Argument on all of the instituted grounds of unpatentability of U.S. Patent No. 6,775,235. Pursuant to Scheduling Order (Paper No. 10), oral argument is currently scheduled for April 20, 2018.

With regard to this particular proceeding, Petitioner requests (without waiving consideration of any issue not listed below) to address the following issues:

1. Whether claims 6 and 22-24 are anticipated under 35 U.S.C. § 102 by Karol (Ex. 1006);
2. Whether claims 6 and 22-24 are obvious under 35 U.S.C. § 103 based on Karol (Ex. 1006) in view of Stallings (Ex. 1011);
3. Whether claims 6 and 22-24 are obvious under 35 U.S.C. § 103 based on Karol (Ex. 1006);
4. Any motions to exclude evidence by Patent Owner;
5. Rebuttal to Patent Owner’s presentation on all matters; and
6. Any additional issues on which the Board seeks clarification.

Petitioner respectfully requests the ability to use audiovisual equipment to display demonstrative exhibits, including the use of a projector and screen that

connects to a laptop computer. Petitioner's counsel requests that an ELMO-type projector be made available for use.
