I. Introduction

1. My name is Joel Williams.

2. I have been engaged by the Exclusive Licensee FatPipe, Inc.

("FatPipe") to investigate and opine on certain issues relating to U.S. Patent No. 6,775,235 B2 ("the '235 patent") in connection with FatPipe's Response to Petition for *Inter Partes* Review in IPR2017-00684.

3. I understand that FatPipe has asserted the '235 patent against Viptela in an on-going patent infringement lawsuit, *FatPipe, Inc. v. Viptela, Inc.*, which was originally filed as Case No. DED-1-16-cv-00182 in the United States District Court for Delaware.

4. In this declaration, I will first discuss the technology background related to the '235 patent and then provide my analyses and opinions on claims 6 and 22-24 for the '235 patent.

5. This declaration is based on the information currently available to me. To the extent that additional information becomes available, I reserve the right to continue my investigation and study, which may include a review of documents and information that may be produced, as well as testimony from depositions that may not yet be taken.

6. In forming my opinions, I have relied on information and evidence identified in this declaration, including the '235 patent, the prosecution history, and
