DECISION
Petitioner's Motion for *Pro Hac Vice*Admission of Matthew S. Yungwirth
37 C.F.R. § 42.10(c)



Petitioner moves unopposed for the admission *pro hac vice* of Matthew S. Yungwirth. Paper 7 ("Motion"). The Board may recognize counsel *pro hac vice* upon a showing of good cause, subject to the condition that lead counsel be a registered practitioner. 37 C.F.R. § 42.10(c).

Petitioner's lead counsel, Joseph A. Powers, is a registered practitioner. Motion 1. In support of the Motion, Petitioner submits a Declaration of Matthew S. Yungwirth. Ex. 1019 ("Declaration"). Upon consideration of the facts set forth in the Motion and Declaration, Petitioner has shown good cause for Mr. Yungwirth to be admitted *pro hac vice* in the proceeding.

It is

ORDERED that Petitioner's Motion is granted and Matthew S. Yungwirth is authorized to represent Petitioner as back-up counsel in the proceeding;

FURTHER ORDERED that Petitioner is to continue to have a registered practitioner represent it as lead counsel in the proceeding;

FURTHER ORDERED that Mr. Yungwirth is to comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials, as set forth in Part 42 of Title 37, Code of Federal Regulations; and

FURTHER ORDERED that Mr. Yungwirth is to be subject to the Office's disciplinary jurisdiction under 37 C.F.R. § 11.19(a), and the USPTO Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101 et. seq.
