Paul,
Valois was in today and we had a very detailed presentation on the Pfeiffer Bi Dose and the Valois Dolphin.

They are both syringe type nasal sprays that are designed to give two doses of the same formulation from a single chamber. Most of the applications are for the vaccine market where you want to give the vaccine in both nostrils. They will not work as dual chamber devices. The piston moves half way for the first shot and then the full way for the second shot. The Zomig nasal spray was the same device, but did not have the two spray feature built in.

Rich, Alex and I have discussed the combo product and we all feel the shortest development route would be either a simple solution or a suspension, depending on the steroid used. That way we can use a multidose spray device such as the Equadel, VP7 or VP3 pumps.
