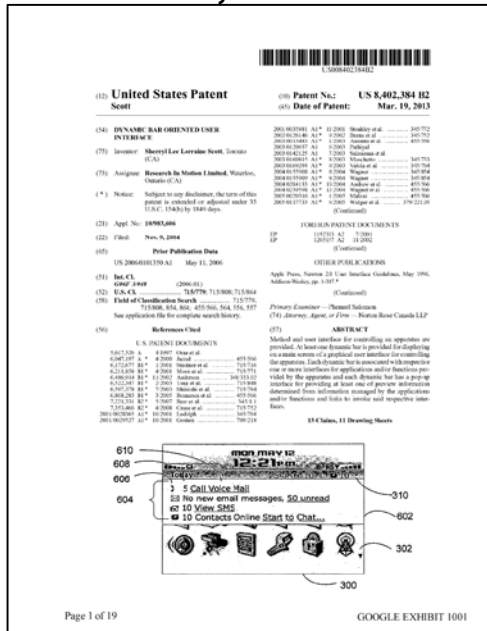
The Parties' Primary Disput

Ground 1 (§ 103 – Cadiz):

- (All Claims) The claimed “**software application**” is obvious by Cadiz’s person-centric interface.
- (All Claims) The claimed “**expanded dynamic bar**” “**invokes the software application**” is not disclosed by Cadiz’s email-centric interface.
- (‘384 patent, Claim 4) The claimed “**method of claim 1**” “**comprises a cellular telephone**” is not disclosed by Cadiz’s email-centric interface.
- (All Claims) Properly construed, the claimed “**a set of additional dynamic preview information**” (“**384 patent, Claim 1**”) “**preview information comprising a selectable link**” is not disclosed or rendered obvious by Cadiz’s person-centric interface.

1. A method for controlling an apparatus of the method comprising:

displaying a dynamic bar on the display;
displaying dynamic preview information on the dynamic preview information being information managed by a software application, the dynamic preview information being updated in response to a change to the information managed by the application;

expanding the dynamic bar to display additional information in response to a first input from a user;
displaying the expanded dynamic bar;

displaying additional dynamic preview information on the additional dynamic preview information determined from the information managed by the software application, the additional dynamic preview information being different from the dynamic preview information displayed in the dynamic bar;

the additional dynamic preview information being updated to reflect the same or different change to the information managed by the software application;

displaying a selectable link embedded in the dynamic preview information to invoke the software application; and

activating the software application in response to a second input invoking the link.
