- III. the proper construction of disputed claim terms;
- IV. the patentability of the substitute claims presented in the contingent Motion to Amend (Paper 22) in view of de Jong (EX_1005) in combination with Tetley (EX_1006) and any arguments raised by Petitioner in its Opposition to the Motion to Amend (Paper 23);
- V. in addition to the Motion to Amend, any issues raised in any other pending motions; and



VI. any additional issues raised by the Board.
