On January 17, 2018, Patent Owner provided a status report on Patent Owner's bankruptcy proceedings, indicating that a creditors' meeting took place on January 2, 2018. Ex. 3003.² Patent Owner's motion for a stay pursuant to 11 U.S.C. § 362(a) (Paper 20) is pending before the Board. Petitioner opposes the motion, and asserts that these proceedings are excluded from the automatic stay. Paper 22.

Given the parties' dispute as to whether the automatic stay applies to these proceedings, we authorize Patent Owner to file a reply in support of its Motion to Stay. In particular, Patent Owner should address Petitioner's contention that these proceedings are excluded from the automatic stay under 11 U.S.C. § 362(b)(4). See Paper 22, 1–9.

For the foregoing reasons, it is

ORDERED that Patent Owner is authorized to file a reply in support of its Motion to Stay no later than February 5, 2018;

FURTHER ORDERED that DUE DATE 1 in the Scheduling Order for each of the above-referenced cases is hereby revised to February 26, 2018, and due dates following DUE DATE 1 will be reset in a future order; and

FURTHER ORDERED that Patent Owner shall provide the Board with a status report on the bankruptcy proceedings by email on or before February 19, 2018.
