On February 2, 2018, Petitioner filed a motion in the bankruptcy court seeking an order finding that the automatic stay pursuant to 11 U.S.C. § 362(a) does not apply to these proceedings or, alternatively, lifting the automatic stay. Ex. 1023.<sup>2</sup> Patent Owner and the bankruptcy trustee have opposed the motion. Exs. 1024, 1025. Due Date 1 in these cases is currently set for February 26, 2018. Given the parties' dispute as to whether the automatic stay applies to these proceedings, we determine it is appropriate to extend Due Date 1.

Accordingly, it is

ORDERED that DUE DATE 1 in the Scheduling Order for each of the above-referenced cases is hereby revised to March 26, 2018, and due dates following DUE DATE 1 will be reset in a future order.
